ightarrow Financing your studies in Germany

1) General Requirements (🖣


- ✓ You must be permanently residing in Germany or have a permanent residence permit
- ✓ You must be under 30 years of age at the start of your Bachelor programme
- \checkmark You must be younger than 35 years of age when you start your Master programme

2) What is supported? 🏀

- ✓ Your first full-time course of study
- Master's programmes may be eligible for funding if they are consecutive

3) How is the amount of BAföG funding determined?

- How much BAföG is paid depends on 3 factors:
 - The student's income
 - The student's assets
 - Income of parents or spouse/life partner
- ✓ As a result, not every student receives BAföG funding
- There is no maximum limit on income or assets, but it is determined individually



- The maximum rate is:
 - below 25 years 752€ per month
 - between 25 and 29 years 861€ per month
 - from 30 years 941€ per month
- Parents' income can reduce the grant rate
- ✓ Students with children, receive an additional allowance of 150€ per month
- ✓ Surcharges of 84€ for health insurance and 25€ for long-term care insurance

5) Good to know! 👰

- BaföG is not a scholarship and must be reimbursed after you finish your studies
- If you change your course of study, you must justify this to the BaföG office
- The duration of BaföG support depends on the standard period of study of your respective degree programme

ightarrow for studying or internship abroad

1) General Requirements



- ✓ You must have your permanent residence in Germany.
- ✓ You must be below 30 years of age at the start of your Bachelor's programme
- ✓ You must be below 35 years old when you start your Master's programme
- ✓ Your university abroad must be equivalent to your German university

2) What is funded? 🔶

- ✓ A study stay of at least one semester or twelve weeks
- ✓ A compulsory internship of at least twelve weeks

3) How high is the grant? \langle

- ✓ Tuition fees (up to 4,600 euros for a maximum of one year)
- ✓ Travel costs for arrival & departure (within EU: 250€ / outside EU: 500€)
- any additional costs for health insurance
- ✓ Higher cost of living outside the EU (vary from country to country)

4) Duration of the grant

You will receive funding for a maximum of one year or two semesters

5) Good to know! 🧐

- Even if you may not receive BAföG in Germany, you still have a chance of receiving the funding when going abroad
- ✓ If you are entitled to BAföG in Germany, you are not automatically entitled to it when going abroad
